| <p>What is the overall deductible?</p> | <p>\$500 member/ \$1,000 family</p> | <p>Generally you must pay all the costs up to the deductible amount before this plan begins to pay. If you have other family members on the policy, they have to meet their own individual deductible until the overall family deductible amount has been met.</p> |
| <p>Are there services covered before you meet your deductible?</p> | <p>Yes: preventive care, provider office visits, prescription drugs, are covered before you meet your deductibles.</p> | <p>This plan covers some items and services even if you haven't yet met the deductible amount. But, a copayment or coinsurance may apply.</p> |
| <p>Are there other deductibles for specific services?</p> | <p>No.</p> | <p>You don't have to meet deductibles for specific services</p> |
